MOTION C. Cane/J. Angle unanimous: To adopt a tentative millage rate of 2.0000 mils.

MOTION J. Angle/C. Cane unanimous: To adopt a tentative Budget of \$12,660,069 as presented.

The tentative millage rate of 2.0000 mils represents a 5.89% increase in the rolled-back rate of 1.8887 for an increase in property taxes of 6.41%.

MINUTES OF SEPTEMBER 9, 2019

A regular meeting of the Board of Commissioners was held on September 9, 2019 and called to order at 7:00 p.m.

PRESENT: Commissioners Angle, Buschman, Cane, and Peluso; Chief Sanford, Deputy

Chief Malpass, Attorney Andrew Salzman and Office Manager Eileen Brown

ABSENT: Commissioner Nelson (previously excused)

Chief Sanford announced the completion of probation of FF/PM Alers, FF/PM Bracy and FF/PM Sharp. He administered the Oath of Office to each, which was repeated by all three. The meeting recessed for pictures and reconvened at 7:22 p.m.

MOTION C. Cane/D. Buschman unanimous: Approve the Minutes of August 5, 2019 (Workshop Meeting) as written.

MOTION C. Cane/J. Angle unanimous: Approve the Minutes of August 12, 2019 (Regular Meeting) as written.

Commissioner Angle read the Treasurer's Report (attached) which showed cash balances of \$8,685,455 in general funds (both operating and reserves) and \$164,102 in impact fees as of July 30, 2019 (\$60,646 in the money market account and \$103,456 in CD #28, which is from impact fees collected). A motion was made by Commissioner Buschman, seconded by Commissioner Cane, to approve the Treasurer's Report as presented.

Chief Sanford reviewed the Chief's Report (attached). He mentioned that the date of the BOCC meeting for the agenda item "ALS First Responder Agreement," was incorrect in his report. The correct date is September 24, 2019.

Chief Sanford distributed the pictures and description of the Commission Meeting tables he found to replace the tables currently in use, and was instructed by the Commissioners to move forward with the purchase.

Chief Sanford then spoke regarding the meeting he had with Commissioner Eggers and Nancy McKibben, concerning several topics including the roundabout that has been proposed by DOT for downtown Palm Harbor. MOTION J. Angle/C. Cane unanimous: Chief Sanford to write a

letter opposing the roundabout, expressing the Department's concerns with response times, the increase in vehicular accidents, and the effect the roundabout would have in distorting the natural flow of traffic.

Deputy Chief Malpass gave the report on Emergency Operations, Fire Prevention and Employee Time Study. (attached)

A discussion followed regarding the Station 68 replacement. Chief Sanford informed the Board that a Building Committee had been established, with the following members: Deputy Chief Breuer, Chair; Commissioner Cane; Fire Marshal Fisher; A-Shift Lt. Fodor and FF/PM Bittner; B-Shift Lt. White and FF/PM O'Neill; and C-Shift Lt. Gonnelli and FF/PM Curtis. The Building Committee will be meeting with Klar & Klar architects, who will be providing a quote and have agreed to do the work for free.

Chief Sanford discussed with the Board that according to the Chief's Agreement, his performance appraisal is on the agenda for the October 14, 2019 Board of Commissioners meeting. The Board decided to readdress Chief Sanford's performance appraisal in 2020, after he has held the Chief of Department position for at least a year.

It was the consensus of the Board for Chief Sanford to research rates and proceed with renewing CD #30, which will be maturing on October 1, 2019, at the best rate available at the time.

MINUTES of SEPTEMBER 23, 2019

FINAL PUBLIC HEARING on 2019/2020 BUDGET

The final public hearing was held September 23, 2019 and called to order at 5:30 p.m.

PRESENT: Commissioners Angle, Buschman, Nelson, and Peluso; Chief Sanford; Deputy Chief Breuer, Attorney Andrew Salzman and Office Manager Eileen Brown

Chief Sanford stated that there were no changes to the Final Budget. Commissioner Angle read the explanation on the percentage of increase in millage from the rolled-back rate.

Commissioner Buschman read Resolution #2019-02 (attached) into the minutes, reflecting a final millage rate of 2.0000 mils per \$1,000 of assessed valuation for fiscal year 2019/2020. A motion was made by Commissioner Angle, seconded by Commissioner Buschman, to adopt Resolution #2019-02 and it passed unanimously.

Commissioner Nelson read Resolution #2019-03 (attached) into the minutes, reflecting a final budget of \$12,660,069 for fiscal year 2019/2020. A motion was made by Commissioner Buschman, seconded by Commissioner Angle, to adopt Resolution #2019-03.

At this point in the meeting, Commissioner Nelson questioned the percentage of increase in property taxes listed as 6.41% on Resolution 2019-02. MOTION D. Buschman/J. Angle unanimous: Amend Resolution 2019-02, due to scrivener's error, to reflect the percentage of increase in property taxes listed as 6.31%.

Commissioner Angle suggested that the figure be checked against the DR-420 to be certain that the percentage was incorrect. It was determined that the correct percentage was <u>6.41</u>%.

MOTION D. Buschman/J. Angle unanimous: Withdraw motion to amend Resolution 2019-02 and MOTION D. Buschman/J. Angle unanimous: Adopt Resolution #2019-02 with the correct percentage of increase in property taxes listed as 6.41%.

Fire Chief's Report

October 14, 2019

1. Countywide EMS System:

- ➤ Data-Driven Focus Group (DDFG) The October DDFG meeting centered on refocusing the group's mission of evaluating data.
- ➤ The ALS First Responder Agreements have been signed by the Board of County Commissioners, with the exception of St. Petersburg and St. Pete Beach.

2. SERP Deployment(s)/Local Disaster Reimbursement:

- ➤ The state has once again requested additional clarification on our reimbursement request for Hurricane Michael. Payment should be forthcoming.
- **3. Apparatus/Vehicles:** Pumper (061) is still for sale, no new update.
- **4. CD** # **30-** Has been renewed at a rate of 1.95% for 12 months with Synovus bank.
- **5. Legislative Update:** No additional bills have been filed.
 - ➤ SB 462 Firefighter Cancer Benefit- We are providing coverage through Star and Shield.
 - ➤ HB 0085 Diesel Exhaust Capture Systems (Casello)- has been filed for the upcoming legislative session.
- **6. Palm Harbor Chamber of Commerce:** A table is reserved for those attending the Evening Extraordinaire Event.
- 7. Florida Association of Special Districts: Our annual renewal has been completed.
- **8.** Palm Harbor 175 Pension Plan: The initial check for \$465,965.85 has been received and deposited.
- **9. Roundabout Meeting:** Staff and Commissioner Peluso met with Nancy McKibben and Craig Fox from the Department of Transportation. Staff conveyed our concerns and current opposition to the roundabout. We focused on the following concerns:
 - ➤ Increased response times associated with the roundabout. Craig Fox stated their data shows a 7.8-second delay for the roundabout.
 - ➤ Pedestrian safety with the increased traffic on Florida Ave. Fox will provide updated information to address our concerns.
 - ➤ Briefly discussed the additional wear and tear on the vehicle while navigating the roundabout.

Serving the communities of Ozona, Palm Harbor and Crystal Beach

- **10. Officer development training:** Last month Howard Cross facilitated leadership training for all of our officers and acting officers. We also started the process of reviewing our strategic plan. The training was well-received, and will likely be provided on an annual basis.
- **11. Annexed property fees:** We are working with the Cities of Dunedin and Tarpon Springs to collect the outstanding ad-valorem taxes. The City of Tarpon Springs has paid all taxes through 2018. The City of Dunedin is looking into the matter and seems cooperative at this point.

12. Mark your calendar:

- ➤ Annual Awards Banquet- Friday, December 6th.
- ➤ Christmas Parade- Saturday, December 21st. This event is still in the planning phases, but initial planning includes a new route taking the parade off Nebraska Ave for safety reasons.



Subject: Consolidation of Bank Accounts

The Department currently has accounts with SunTrust, BBT, Synovus, and Patriot banks. The SunTrust and BBT accounts are checking and savings accounts, while Synovus and Patriot are certificates of deposits.

Staff is evaluating the consolidation of all bank accounts to one provider. Currently, we pay over \$4,000 a year in fees, and we are under the impression these fees could be eliminated or greatly reduced by consolidating.

This would not replace our current practice of shopping for the best rate when renewing a certificate of deposits.

With the Board's approval and assistance from Commissioner Nelson, the staff will consolidate all checking and savings accounts to one provider.

- Committee members will begin visiting fire stations on Friday, September 20th.
